ORDER

Subject: Allocation of 8 MW capacity to H.P Govt. Energy Development Agency (HIMURJA) implementation of rooftop solar power plants in residential, institutional and social sectors under central financial assistance (CFA) scheme of MNRE.

With reference to online proposal received from HIMURJA on SPIN Portal (proposal id: 781/05/2018/sna dated 31.05.2018) for implementation of 8 MW grid connected roof top solar power plants in Himachal Pradesh, I am directed to convey sanction of President of India for allocation of 8 MW capacity to HIMURJA for implementation of RTS projects in residential, institutional & social sectors in Himachal Pradesh as per the provisions of grid connected rooftop and small solar power plants programme notified vide 03/88/2015-16/GCRT dated 04.03.2016 & 02.09.2016 and amendments thereof.

2. The project commissioning timeline shall be 15 months from the date of MNRE sanction or timeline specified in the work order, whichever is less. This Ministry shall also be kept apprised about the progress of the project related activities on monthly basis by HIMURJA. The release of advance CFA may be considered upon receipt of claims from the agency.
3. HIMURJA will follow all the terms and conditions stipulated in the Administrative Approval no. 03/88/2015-16/GCRT dated 04.03.2016 & 02.09.2016, in vogue and any amendments thereof. For calculation of central financial assistance (CFA), the revised benchmark cost of FY 2018-19 would be applicable for the project.
4. HIMURJA shall be liable for recovery of the whole or part amount of CFA, with applicable penal interest, in case of non-compliance of the provisions of the scheme.
5. In terms of Rule 230 (7) of GFR 2017 and instructions of DoE, HIMURJA shall record the receipt of CFA and the expenditure therefrom in the EAT module of PFMS.
6. In terms of the Rule 230 (1) of GFR, HIMURJA will certify that it has not obtained or applied for grants for the same purpose or activity from any other Ministry or Department of the Government of India or State Government.
7. In terms of provisions contained in Rule 236(i) of GFR 2017, the account of HIMURJA shall be open to inspection by the sanctioning authority and audit (both by CAG of India and Internal Audit by the Principal Accounts Office of the MNRE), whenever the organization is called upon to do so.



8. HIMURJA will furnish year wise Utilization Certificate (UC) in the prescribed format of GFR-12(A) and Audited Statement of Expenditure (ASoE), along with detailed progress report periodically, as per provisions of the scheme. HIMURJA shall submit online project completion reports on SPIN portal for settlement of the project.

9. As per Rule 234 of GFR-2017, the sanction has been entered at S. No. 37 & Page No. 7 in the Expenditure Register of this Division.

10. This issues with the approval of Secretary, MNRE.
